WHEREAS, Forsyth Technical Community College owns a 1995 Ford Truck, VIN# IFTEF25N6SNA78664, which vehicle is surplus to the needs of Forsyth Technical Community College; and

WHEREAS, County staff recommends that the above-described vehicle be accepted by Forsyth County;

BE IT FURTHER RESOLVED that the Chairman or the County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, the necessary documents to receive title to the said vehicle on the conditions that it shall be used or disposed of and the proceeds thereof used by Forsyth County as an addition to the County's active fleet and that Forsyth County will waive all rights to make any claims against Forsyth Technical Community College relating to any failure of performance of the said vehicle, to which the County agrees by accepting title to the vehicle, all subject to a pre-audit certificate therein by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
