Meeting Minutes October 31, 2017 – 5 p.m.

Meeting Called to Order

A meeting of the Forsyth County Board of Elections was called to order in the second floor meeting room on October 16, 2017 at 11:00 a.m., Chairman Raymond presiding.

Pledge of Allegiance

Chairman Raymond led the pledge of allegiance.

Moment of Silence

Chairman Raymond led a moment of silence.

Public Comment Session

Chairman Raymond called for public comments, none offered. Member Campbell moved to close public comments, Secretary Russell seconded; **Motion carried unanimously**.

Approval of Absentee Ballots

Ms. Gary recommended 113 Absentee ballots (By-Mail = 14, One-Stop Early Voting = 99) for approval. Chairman Raymond called for questions or comments from the Board members. Secretary Russell motioned to accept staff recommendations, Member Campbell seconded; **Motion carried unanimously**.

Approval of Precinct Officials

Ms. Teal presented the Board with the names of precinct officials that wished to fill a Judges position rather than the Chief Judges position and a list of precinct officials selected to fill vacancies. Secretary Campbell moved to approve staff recommendations; Chairman Raymond seconded; **Motion carried unanimously**.

Approval of Minutes

Secretary Russell reviewed minutes and moved to approve as presented for September 19, 2017, October 10, 2017, and October 16, 2017; Secretary Campbell seconded; **Motion carried unanimously.**

Other Business

Director Tsujii provided an update on a 3-judge panel ruling regarding the composition of the State Board of Elections noting the order has been sent to the North Carolina Supreme Court for review.

Mr. Tsujii also provided an update on the meeting with the State Board of Elections and Ethics Enforcement and the North Carolina Association of County Commissioners (NCACC) on the deadline to decertify equipment. Director Tsujii stated that the North Carolina State Board of Elections would submit legislative language to the North Carolina General Assembly to extend the deadline. Member Campbell inquired what if any argument was made against the extension as well as what the timeline for the review by the Court; Director Tsujii stated that none had been provided for either.

Chairman Raymond inquired of need for closed session; none offered.
