FORSYTH COUNTY BOARD OF ELECTIONS BOARD MEETING MINUTES – OCTOBER 25, 2011

Call to Order

An Absentee Ballot meeting of the Forsyth County Board of Elections was held in the Cooper Cardwell Elections Room on October 25, 2011. The meeting convened at 5:34 PM, Chairman Linda Sutton presiding.

Approval of Minutes

The Board discussed that resolution documents were mailed to the State Board of Elections and the County Attorney's office. The Forsyth County Board of Elections had been served with the Forsyth County Superior Court File Number 11 CVS 7133 claim. Mr. McGuckin would be joining the meeting next week for advisement. The County Attorney and/or a State Board member may be arranged to further inform the Board on open session laws and administrative procedures. Chairman Sutton agreed to schedule an advisor to attend the meeting next Tuesday. Mr. Joyner acknowledged that the Early One Stop Voting began on Thursday, October 20, 2011 and that 27 voters had voted since that time. Member Dills questioned whether there was data available related to cost amount per vote. Mr. Joyner said that statistics were available for a report and that the usual cost per one stop location was \$5000 per election. The municipalities do not request other one stop sites in addition to the required office location.

Chairman Sutton reminded the Board to review the Duties of Director document. Mr. Joyner agreed to email the document and to place it on the next meeting agenda.
