- 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding P-GC-Pan of cooked ribs at 47. Air temp of unit 54. All food temperatures are to be maintained below 45F. Electrical breaker checked and turned on, air temp cooled to 44. Ribs iced down. Need to address the electrical issue.
- 4-203.11 Temperature Measuring Devices, Food-Accuracy PF- One thermometer read 39F (4C) in ice water. A thermometer that is scaled to read in Celsius and Fahrenheit are to be accurate to +/-1C. Manager removed the thermometer from cook area, supplied an accurate one and will replace the batteries.
- 35 3-602.11 Food Labels PF- Bread crumbs, corn meal and flour out of their original container not labeled. Any item that is not easily distinguishable (pasta, nuts) are to be labeled with their common name if not in the original package. Manager addressed the issue.
- GC- 6-501.111 Controlling Pests PF- 1 or 2 live flies in the kitchen and storage areas. Facility is to be maintained pest free. Manager is currently using a pest control company to address the issue. / 6-501.112 Removing Dead or Trapped Birds, Insects, Rodents and other Pest C- Dead fly in reach-in freezer on make line and in walk-in meat cooler. Dead pests shall be removed from the premises at a frequency to prevent their accumulation. -Manager had employee clean and remove the pests.
- 3-305.11 Food Storage-Preventing Contamination from the Premises C- Soup, slaw, cheese and other items on the CA line not covered. Liquid eggs stored in the walk-in opened and uncovered. Cookie dough uncovered in the reach-in unit. Food shall be protected from dust, splash or other contamination. Employees are reaching over the food items to get plates of food and something may fall into the food. Manager covered the items. / 3-305.14 Food Preparation C- Employee prepared a drink by running the cup through the ice and not using the ice scoop. During preparation food is to be protected from environmental contamination.
- 2-304.11 Clean Condition-Outer Clothing C- 2 employees wiped their hands on their aprons and pants. Food employees shall wear clean outer clothing to prevent contamination of food, equipment, utensils, linens, and single service articles. Management addressed the issue, however, additional training is needed.
- 4-901.11 Equipment and Utensils, Air-Drying Required C- All pans, dishes, containers, lids and other food contact surfaces stacked wet. After washing, rinsing and sanitizing, equipment and utensils shall be air dried to prevent bacterial growth. Items were re-washed./ 4-903.11 (A), (B) and (D) Equipment, Utensils, Linens and Single-Service and Single-Use Articles-Storing C- Forks stored in the silverware rack with the eating parts up. Clean equipment and utensils shall be stored covered or inverted. Manager pulled the items to be re-washed./ Shelving that stores clean containers is dirty and under food preparation surfaces where food debris is accumulating. All dishes shall be stored in a clean, dry location where they are not exposed to splash, dust or other contamination. Items moved and shelving cleaned.

Surfaces subject to scratching and scoring shall be resurfaced or replaced if they can not longer be effectively cleaned and sanitized. Manager stated that new cutting boards have been ordered. / 4-501.11 Good Repair and Proper Adjustment-Equipment C- Condensation leak in freezer and salad plate cooler in salad prep area, damaged gasket on the walk-in cooler, shelving broken in the freezer, cap missing on wall of meat cooler and the racks for the dish machine cracked and damaged on the edges. All non-food contact surfaces and equipment are to be maintained in good repair.
- 4-204.114 Warewashing Machines, Internal Baffles C- Curtain removed between wash and rinse area in the dish machine. Warewashing machine wash and rinse tanks shall be equipped with baffles, curtains or other means to minimize internal contamination and insure the machine works properly. Curtain put in machine./ 4-501.14 Warewashing Equipment, Cleaning Frequency C- internal spray nozzles clogged with lemons and other items, the curtains on the clean end of the dishmachine dirty, the clean drain board of the dishmachine dirty and the exterior of the dishmachine dirty at door and under side of the equipment. A warewashing machine and drainboards are to be cleaned at a frequency necessary to prevent recontamination of equipment and utensils and ensure the equipment performs correctly. / 4-501.15 Warewashing Machines, Manufacturers' Operating Instructions C- The dishmachine conveyor belt does not allow for the racks to completely exit after washing. The conveyor speed shall be
- 4-602.13 Nonfood Contact Surfaces C- Shelving in walk-in and dry storage areas dirty, lower shelving of tables and inside of reach-ins dirty. All equipment is to be clean to sight and touch.
- 6-501.12 Cleaning, Frequency and Restrictions C- Floors drains contain debris and other items, trash and other food items on the floor in the bar, standing water in meat cooler and dish/can storage area. Debris under equipment on the line. Facility's are to be clean at a frequency to maintain clean./ 6-501.114 Maintaining Premises, Unnecessary Items and Litter C -Hose laying in the can wash. The premise shall be maintained clean./ Brooms sitting on the floor in the CA area. Brooms need to be properly stored to prevent rodent harborage areas.
