- 37 3-305.11 Food Storage-Preventing Contamination from the Premises - C- REPEAT. Three bakery dough boxes were stored on floor of walk-in freezer. Food shall be protected against contamination by storing food at least 6 inches above the floor. CDI- Boxes were removed from floor during inspection.
- 42 4-903.11 (A), (B) and (D) Equipment, Utensils, Linens and Single-Service and Single-Use Articles-Storing - C- 0 pts. Sanitizer drain board is within splash zone of handwashing sink in deli area. Clean utensils shall be stored in a manner necessary to prevent contamination. Install splash guard or create 18 inches of separation between handwashing sink and sanitizer drain board.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C- Equipment repair/replacement is needed on the following: loose spring hook at deli three compartment sink; missing curtain in walk-in cooler; adjust broken door under pizza hot holding unit; missing self cap on clean utensil shelf in bakery area; seal display cooler frame. Equipment shall be maintained in good repair.

Cleaning is needed on ventilation hood system above pizza oven, plumbing under bakery three compartment sink, under bakery prep table, inside two cabinets under pizza hot holding unit, and shelf under pizza oven. Nonfood-contact surfaces shall be kept clean.
- 53 6-501.12 Cleaning, Frequency and Restrictions - C- Floor cleaning needed under shelving units in walk-in freezer and inside walk-cooler. Physical facilities shall be kept clean.
- 54 6-303.11 Intensity-Lighting - C- REPEAT. Low lighting measured at prep sink in deli area 24-36 foot candles, chicken brooding station 32-34 foot candles, and fryer in deli area 35 foot candles. Lighting shall be at least 50 foot candles in areas of food prep. Increase lighting.
