- 53 6-501.12 Cleaning, Frequency and Restrictions - C- The diamond plate floor in the freezer has build up (food, soil, etc). Floor in the room with the hot water heater has food debris in the corners. The half wall next to the rotisserie oven has grease build up. Floors and walls shall be maintained clean.
