Meeting Called to Order

An emergency meeting of the Forsyth County Board of Elections was called to order in the second floor Board Room on November 21, 2018 at 1:00 p.m., Chairman Russell presiding.

Pledge of Allegiance

Chairman Russell led the pledge of allegiance.

Moment of Silence

Chairman Russell led a moment of silence.

<u>Public Comment Session</u> Chairman Russell opened public comments:

Vice-Chairperson Campbell moved to close public comments; Secretary Durrah seconded; **Motion** carried unanimously.

The Board and Director Tsujii addressed Mr. Miller's questions and concerns regarding election day incidents and electioneering.

Approval of Additional Provisional Ballots

Director Tsujii provide the Board with an overview of the seven retrieved provisional ballots stating that they were secured within the office in the provisional ballot bag for Precinct 501 – St. Andrews Methodist Church. Mr. Tsujii assured the Board that chain of custody and security of the ballots had been maintained. Director Tsujii presented one provisional for partial approval, six for full approval as they were precinct transfers, and two for disapproval due to voters not being registered. Secretary Durrah moved process the provisional ballots per Mr. Tsujii's recommendations; Vice-Chairperson Campbell seconded; **Motion carried unanimously**.

Director Tsujii presented to the Board two additional provisional ballots to be discounted due to voter failure to contact office as per letter sent due to citizenship boxes not being checked. Secretary Durrah moved to discount the provisional ballots per Mr. Tsujii's recommendation; Vice-Chairperson Campbell seconded; **Motion carried unanimously**.
