Meeting Minutes February 17, 2022 – 5:00 p.m.

#### **Meeting Called to Order**

A regular meeting of the Forsyth County Board of Elections was called to order on February 17, 2022 at 5:08 p.m. with Chairperson Durrah presiding.

#### **Pledge of Allegiance**

Chairperson Durrah led the Pledge of Allegiance.

#### **Moment of Silence**

Chairperson Durrah called for a moment of silence.

#### **Public Comments**

Chairperson Durrah called for public comments. There were no public comments.

#### **Review of 2021 and Post-Election Report**

Deputy Director Bobadilla and Ms. Danielle Malone presented the 2021 post-annual and November 2, 2021 post-election report to the Board, highlighting the accomplishments of the Board of Elections office and lessons learned.

Director Tsujii also presented a five year plan outlining long-term goals for 2021-2025.

#### **Approval of Ballot Printing and Packaging Services Contract**

Director Tsujii presented the Board with the Ballot Printing and Packaging Services contract for review and approval, providing insight about the informal bidding process and explaining the need for contracting ballot printing and packaging services. Member Doomy moved to approve the resolution and contract with AlphaGraphics of Downtown Raleigh (Capital Marketing Solutions, LLC), Member Harvey seconded; **Motion carried unanimously.** 

# Review and Approval of FY2022-23 Budget

Director Tsujii provided a detailed overview of the FY 2022-2023 budget to be recommended to the Board of County Commissioners. providing insight on office and operations funding, for the November 8, 2022 general election, and intended earmark of contingency funds. Secretary Jourdan moved to approve the FY 2022-23 budget recommendation, Member Doomy seconded; **Motion carried unanimously**.

Member Draper moved to approve the meeting minutes for the January 22, 2022 board meeting, Member Doomy seconded; **Motion carried unanimously**.
