- 39 3-304.14 Wiping Cloths, Use Limitation - C 0 points. Wet wiping cloth found on counter top along serve line. Wet wiping cloths must be stored in a sanitizer solution of appropriate strength. CDI. Wiping cloth moved to sanitizer bucket.
- 41 3-304.12 In-Use Utensils, Between-Use Storage - C 0 points. Scoop for cheese in prep unit stored with handle in cheese. When storing in-use utensils, be sure that the handle protrudes out of the food to avoid contamination. Recommend utensil with longer handle so handle may protrude from cheese.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C Repeat violation. Clean food debris from shelves of walk in cooler. Clean insides and outsides of all stainless steel equipment, shelves and storage cabinets along cook line. Clean mold from gaskets of refrigeration and freezer units along cook line. Clean mold from top inside of left ice bin.
- 53 6-501.12 Cleaning, Frequency and Restrictions - C Repeat violation. Clean floors under equipment along cook line and in walk in cooler. Clean can wash.
