

- 6 2-301.12 Cleaning Procedure - P/ 2-301.14 When to Wash - P- Employee washed their hands then turned off the knob with their bare hands (recontaminating them). Employees are to wash their hands for 10 to 15 seconds and avoid recontamination. CDI- Employee re-washed their hands and used the paper towel to turn off the knob, avoiding contamination.
- 14 4-501.114 Manual and Mechanical Warewashing Equipment, Chemical Sanitization-Temperature, pH, Concentration and Hardness - P- Dish machine tested less than 50 ppm chlorine. Quat sanitizer in 4 comp sink was greater than 400 ppm. Sanitizer shall be provided at the proper concentration per manufacturers specifications. CDI- Chemical company adjusted Quat to 200 ppm and the dish machine was primed and read 100 ppm.
- 46 4-302.14 Sanitizing Solutions, Testing Devices - PF- 0 points- No test strips available to test dish machine. A test kit or other device that accurately measures the concentration of sanitizing solutions shall be provided. CDI- Chemical company provided chlorine test strips.
